4.1 Description of first aid measures

Have victim rinse mouth thoroughly with water. Give water to dilute the material if victim is alert and not convulsing. Induce vomiting immediately as directed by medical personnel. If spontaneous vomiting occurs, have victim lean forward with head down to avoid breathing in of vomits, rinse mouth and administer more water. Never give anything by mouth to an unconscious person. SECTION 5: Firefighting measures

5.1 Fire Extinguishing Media

5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture:

Fire water contaminated with this material must be contained and prevented from being discharged to any waterway, sewer or drain.

Hazardous thermal decomposition products:

During fire, irritating and toxic gases will be released due to thermal decomposition or combustion. Non-combustible, substance itself does not burn but may decompose upon heating to produce corrosive and/or toxic fumes. May react with chemically reactive metals such as aluminium, zinc, copper to release hydrogen gas which can form explosive mixtures in air (see section10).

5.3 Additional provisions:
