By inhalation:

Remove to fresh air. If not breathing give artificial respiration. If breathing is difficult, give oxygen. Do not give mouth-to-mouth resuscitation if victim ingested or inhaled the substance. Keep person at rest and warm. Treat symptomatically and supportively as and when required. Obtain medical advice if necessary.

By skin contact:

Hazards from the substance or mixture:

Fire water contaminated with this material must be contained and prevented from being discharged to any waterway, sewer or drain.

Hazardous thermal decomposition products:

During fire, irritating and toxic gases will be released due to thermal decomposition or combustion. Non-combustible, substance itself does not burn but may decompose upon heating to produce corrosive and/or toxic fumes. May react with chemically reactive metals such as aluminium, zinc, copper to release hydrogen gas which can form explosive mixtures in air (see section10).

5.3 Additional provisions:
